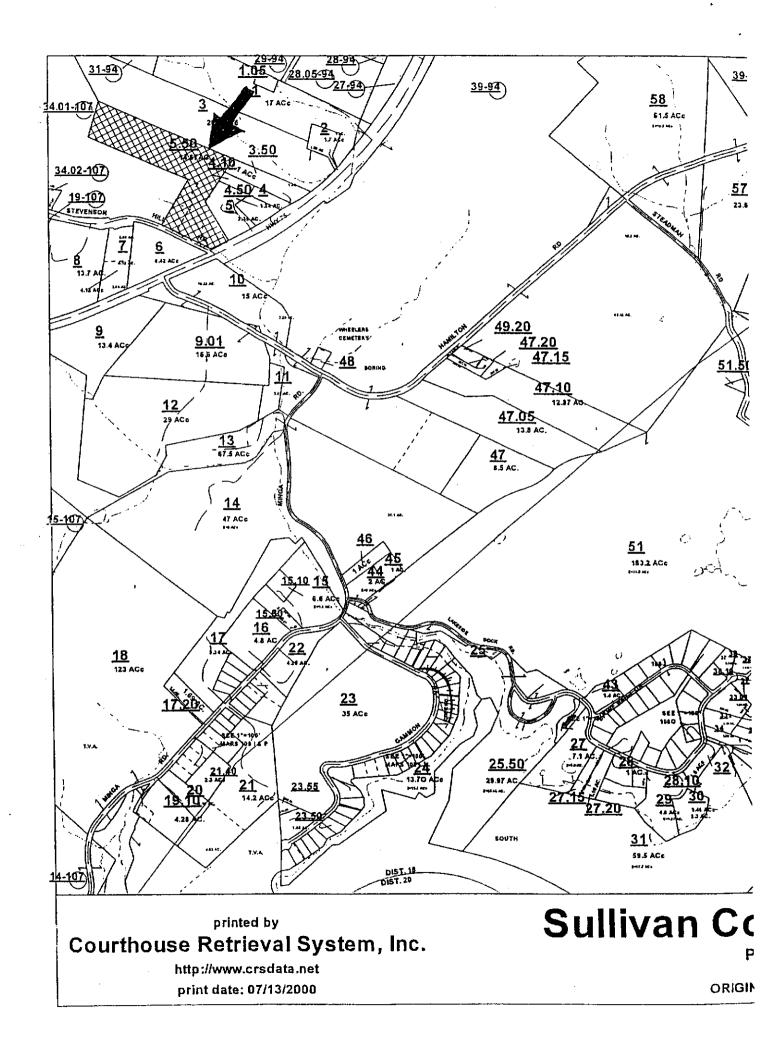

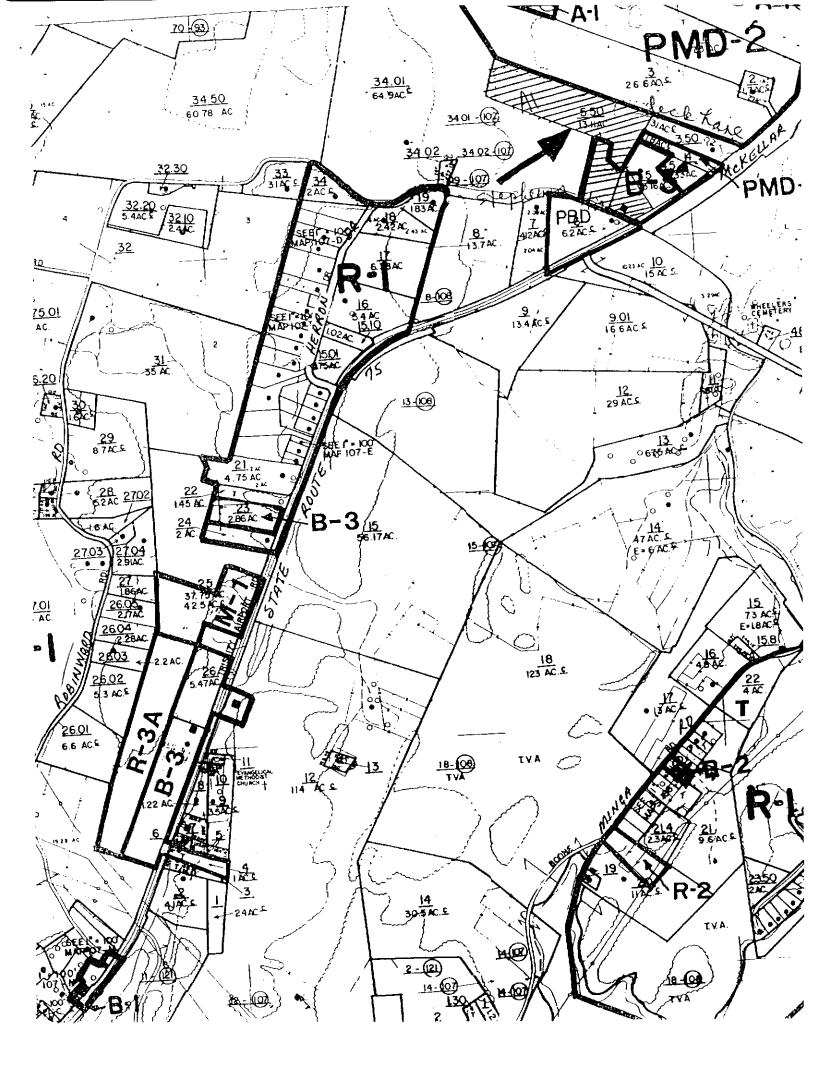

Staff Field Notes:

- This property is approximately 1.92 acres and does not front on a public road; the access is a private drive/easement.
- The parcel has been used for a general contractor's storage and office. Mr. Harrison has been a contractor and has had a business license since April of 1986.
- According to county records available, the detached garage was built in 1988. Staff considers this building and contractor's office as a legal but non-conforming use and structure (grandfather clause).
- The site has poor access and very poor visibility, as the driveway is at the crest of a hill not suitable for general business and retail traffic.
- While this area is within a planned growth area, commercial growth on a rural residential road is not appropriate or compatible with the single-family homes surrounding this site.
- Staff cannot recommend in favor of this rezoning classification, as the site is surrounded by established singlefamily homes, large tracts and farms, is not suitable for the broad range of business uses permitted under B-3, and the traffic would be flowing through neighboring land via an easement.
- Any future commercial districts in this area should be on collector roads, be extensions of existing and established districts, should have public services, and direct public access without creating a nuisance on neighboring residences.

Dear Mrs. Torbett:

On April 17, 2003, the Kingsport Regional Planning Commission made the following recommendations concerning county cases.

04-06 County Rezoning 393 Pearl Lane (03-101-00001)

Paul Spears, property owner, requested a county rezoning of ~10 acres from PRD, Planned Residential District, to A-1, Agricultural District. The property was located on the southern side of Pearl Lane (Sullivan County tax map 78, parcel 94). The rezoning application stated that the proposed use was to "protect against multi-unit housing for front property owners." Staff recommended approving the rezoning as requested for the following reasons:

- 1. The rezoning is compatible with the surrounding county and city agriculture zoning districts.
- 2. The possible land uses in the A-1 zone would be compatible with the surrounding land uses.
- 3. The property owner submitted the request.
- 4. The East Kingsport Land Use & Transportation Study (2003) recommended the property for conservation, residential, and agricultural land use.

Staff stated that trailers on single lots were permitted in the A-1 county zone, however, a public street would have to be constructed with sidewalks and meet the minimum lot size requirements for the A-1 zone. Bruce Martin, front property owner, opposed, and questioned rezoning property from a zone that permitted apartments to a zone that permitted trailers on single lots. Mr. Spears stated difficulty developing it under the PRD zone, which he said the property was zoned when he purchased it. On a motion by Doug Releford, seconded by Mike McIntire, the Commission voted unanimously, 7-0, to accept the Staff rationale to rezone the property from PRD, Planned Residential District to A1, Agricultural District.

EXISTING LAND USE:	Single-family residence.	
PROPOSED USE:	The application states, "For protection against multi-unit housing for front property owners".	
SURROUNDING COUNTY	& CITY ZONING AND LAND USE:	
North:	County A-1. Vacant, wooded lot.	
South:	City A-1, and city B-3, General Business District. There is a commercial business accessed from Browder Drive. There is wooded property in the agriculture zone of the City.	
East:	County A-1. On the southern side of Pearl Lane are two houses, a vacant property, a utility building, vacant property, and a residence adjacent to Browder Drive. On the northern side of Pearl Lane there is agriculture use, and a residence adjacent to Browder Drive.	
West:	County A-1. Four houses on the southern side of Pearl Lane, Rocky Top Campground on the northern side of Pearl Lane, and a cluster of single- family houses at the intersection of Pearl Lane, and Rocky Branch Road.	
LAND USE PLAN (S):	The site is outside the city 2010 Conceptual Land Use Plan (<u>Kingsport</u> Land Use Plan, 1988).	
UTILITIES:	The Kingsport Water Division stated that a 12-inch diameter city water line is available to the property. The Kingsport Sewer Division stated that two city sewer lines are available measuring 8-inches in diameter adjacent to Pearl Lane, and 6-inches in diameter from Browder Road.	

TRANSPORTATION: The site requesting rezoning is located adjacent to the southern side of Pearl Lane, which has an approximate 24-foot pavement width. The <u>Major Street & Road Plan</u> (2000) designates Pearl Lane as a 60-foot collector street.

PHYSICAL CHARACTERISTICS:

The property requesting rezoning measures ~ 50 feet adjacent to Pearl Lane, extending south ~ 150 feet before widening ~ 600 feet for an approximate depth of 600 feet. The property rises from the front property line to form a hill with a single-family residence and accessory structure on the top.

CITIZEN RESPONSE: None.

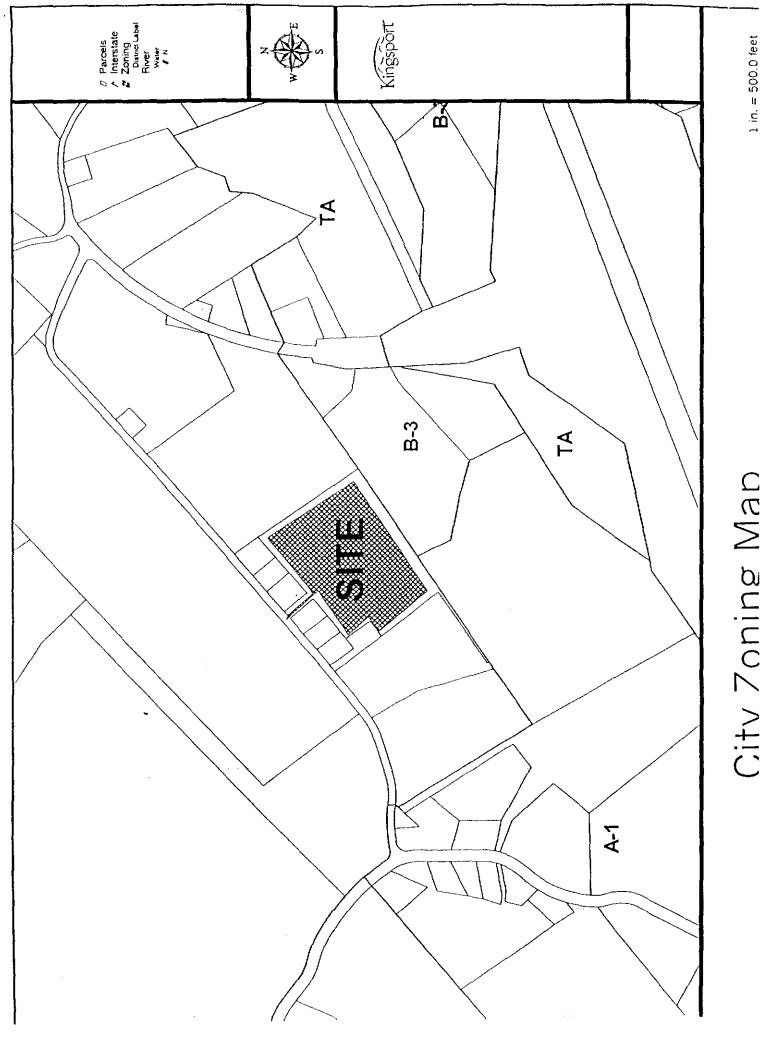
OPTIONS: The Planning Commission's options are the following:

In order to ensure good design and buildable areas in any proposed lot, any portion of a lot contained within the pipe-stem (access or driveway area) or within any designated floodway areas, as identified by the best available data, shall not be applied to the minimum lot size standard, as required by the zoning district.

Jerry Dykes spoke against lot sizes in zoning regulations.

Mr. Peterson made the motion, seconded by Mrs. Mullins, to approve the text amendment change. The motion to change the text amendment passed unanimously.

E. Rezoning Requests

(1) File No. 3/03/01 Mike L. Bauguess

Reclassify A-1/B-3 property on Stevenson Hill Road to PMD-1. Property ID. No. Tax map 108, Parcel 5.50 located in the 18th Civil District.

Mr. Tom McKee was present and spoke on behalf of the rezoning request.

No one was present in opposition.

Staff Comments:

- This property is approximately 14.67 acres and has existing commercial businesses (Trading Post) on site fronting Hwy 75 across from the Tri-Cities Regional Airport.
- The rear portion of the land has not been developed but has recently been re-platted into two additional tracts.
- There are public utilities to serve this property; although it is currently served by septic. Johnson City has not expanded the sewer at this time.

Due to the proximity to the airport and industrial centers, the trend for this rezoning request in this area, and the compatibility with the adjacent commercial and manufacturing sites, staff recommends in favor of this rezoning request.

Mr. Bronner made the motion, seconded by Mr. Dutton, to approve the rezoning. The motion to recommend approval for the rezoning passed unanimously.

(2) File No. 3/03/02 Larry Harrison

Reclassify R-1 property at 615 Chadwell Road to B-3. Property ID. No. Tax map 14, Parcel 15.12 located in the 10th Civil District.

Mrs. Alexandria Ferrari spoke on behalf of Larry Harrison. She stated that Mr. Harrison would like to start a small gun and pawnshop on the property in question.

Mr. Jim Devalt asked why Mr. Harrison would not be grandfathered. Ambre Torbett explained the grandfathering process to Mr. Devalt.

Loal Harris expressed his concerns of liability, water drainage and traffic safety.

Nina Jones expressed her concerns of traffic safety, water drainage and mailbox problems.

Jerry Jones expressed his concern about not wanting a business in his neighborhood.

Paul Hoover expressed his concerns about traffic on Chadwell Rd.

Staff Comments:

This property is approximately 1.92 acres and does not front on a public road; the access is a private a business license since April of 1986.

- According to county records available, the detached garage was built in 1988. Staff considers this building and contractor's office as a legal but non-conforming use and structure (grandfather clause).
- The site has poor access and very poor visibility, as the driveway is at the crest of a hill not suitable for general business and retail traffic.
 While the provident of the state of th

While this area is within a planned growth area, commercial growth on a rural residential road is not appropriate or compatible drive/easement.

- The parcel has been used for a general contractor's storage and office. Mr. Harrison has been a contractor and has had with the single-family homes surrounding this site.
- Staff cannot recommend in favor of this rezoning classification, as the site is surrounded by established single-family homes, large tracts and farms, is not suitable for the broad range of business uses permitted under B-3, and the traffic would be flowing through neighboring land via an easement.

Any future commercial districts in this area should be on collector roads, be extensions of existing and established districts, should have public services, and direct public access without creating a nuisance on neighboring residences.

Mr. Bronner made the motion, seconded by Mr. Peterson, to deny the rezoning. The motion to recommend denial of the rezoning passed unanimously.

F. Bond Release

(1) Mr. Lewis Buckles, Green Auto Sales, Hwy 11-E, Piney Flats TN

Mr. Buckles was present and spoke on behalf of the bond. He stated that all regulations had been met.

- Staff recommends approval for the release of the bond of \$4,200. All site plan requirements have been completed and meet the zoning requirements.
- Staff noticed that some of the required evergreen trees appear to be dying. Any trees that do not survive must be replaced and maintained. All other landscaped areas must be maintained as well.

Motion was made by Peterson and a second by Bronner to approve the Bond Release. The motion to approve the Bond Release passed unanimously.

G. Subdivisions

(1) George Browder Property, Final

<u>Staff Comments:</u>

The farm owner is proposing to divide 3 tracts to be sold at auction.

Motion was made by Dutton and a second by Bronner to approve the final subdivision. The motion to approve the final subdivision passed unanimously.

(2) Barb Lots, Preliminary & Final

Staff Comments:

All signatures certify code compliance. No one present to represent the case. Staff briefed the members.

Motion was made by Dutton and a second by Mullins to approve the Preliminary and Final subdivision. The motion to approve the preliminary & final subdivision passed unanimously.

(3) Lois Marcella Burgess and grandson, Preliminary & Final

Staff Comments:

The lot closest to the road has an unstudied stream, which would require creek crossing permits from TDEC. Staff is waiting for a revised plat with signatures.

All signatures certify code compliance.

Motion was made by Peterson and a second by Bronner to defer the subdivision. The motion to defer the preliminary & final subdivision passed unanimously because of a lack of representation.

(4) Rosemary Court Villas, *Preliminary*

Staff Comments:

This site was split into two parcels, but has recently been platted to recombine the tracts (Kingsport Planning Commission). The property is approximately 2.472 acres total and can accommodate 14 units total, as the density for this district for single-family homes is 1 dwelling unit per 7,500 square feet or 5.88 per acre. This plan meets the minimum setbacks, density, parking and access requirements with no room for error. The drainage plan will be incorporated into the erosion and sediment control plan. This will require a TDEC construction permit for stormwater. Staff recommends preliminary approval for these patio homes as the plan meets the county zoning requirements for the R-3 district. Pursuant to Title 66 of the TCA, Horizontal Property Act Regime, a final as-built survey plat must be submitted for Planning Commission approval to be recorded with the Master Deed and Home-Owners Association. Please note, this is not a subdivision of land, rather a plan for individual ownership of the unit and common ownership of the land.

Motion was made by Peterson and a second by Bronner to approve the preliminary subdivision. The motion to approve the preliminary condominium plan passed unanimously.

(5) Confirmation of Minor Subdivision Plats for March 2003.

Motion made by Dutton and a second by Bronner to confirm the approval of the subdivisions. The motion passed unanimously.

H. Site Plans

(1) Airport Business Park, Site Plan

Staff Comments:

This plan is for a 5,000 square foot building located on Deck Lane in Blountville, near the airport. Gammon Creek runs along Hwy 75 on this side of the road. The surveyor has calculated the elevation of the site and building pad in relation to the flood elevation, to prevent flooding of structures. All setbacks illustrate landscaping of shade trees and evergreen trees to the rear along non-commercial zones. Johnson City provides all utilities to this site. Staff recommends approval of this new development, as zoning code requirements have been planned.

Mr. Kem Richardson and Mr. Cline were present to represent the case. They explained that most of the grass would not be disturbed near the creek and that a detention pond would be constructed on site to filter out sediment from stormwater discharge.

Motion was made by Peterson, seconded by Mullins to approve the site plan. The motion to approve the site plan passed unanimously.

(2) Affordable Dentures in Bluff City Area, Site Plan Expansion of a Non-Conforming Use

Staff Comments:

The purpose of this expansion is to add 512 square feet in the rear for a bathroom, additional waiting area and three more dental chair exam rooms. This structure and use is considered legal but non-conforming as it was established prior to zoning and is currently zoned A-1. The surrounding zoning is A-1. According to the plans, no parking or landscaping will be affected by this expansion. Staff recommends approval of this plan.

- Where will the exterior HVAC system be relocated?
- Will any additional trees be planted to replace those that will be destroyed during construction?

Mark LaRue - was present to represent the request

Motion was made by Mullins, seconded by Dutton to approve the site plan expansion. The motion to approve the site plan expansion passed unanimously.

(3) Lamar Advertising, Site Plan Expansion

Staff Comments:

11210

- This is a legal but non-conforming structure in a B-4 zone.
- The current billboard is too close to the road and does not meet the setbacks for the B-4 zone.
- The proposed replacement billboard will be V-shaped/Double-Sided and will be set the same distance still not meeting the setbacks for this zone.
- Lamar Advertising has recently sued municipalities finding loopholes in their zoning codes. The court has established that section 13-7-208 of the TCA applies to counties as well as cities and therefore a billboard is considered a commercial facility (as opposed to a sign) and therefore would be allowed to expand as a non-conforming structure, per Planning Commission review and approval.
- One caveat to this TCA and court ruling is that this billboard may be allowed to expand provided there is room for expansion.
- Staff viewed site and materials as provided. Staff believes there is plenty of room for this new billboard (replacement) to meet all of the required zoning setbacks required for the B-4 district (50 feet on Fort Henry Drive and VFW Road, 25 feet rear and 30 feet side.
- There are many legal, but non-conforming billboards in the area and Sullivan County operated by this company and others. Any decision by the Planning Commission will set precedence for future billboard expansions or replacements.
- Staff recommends approval of the replacement billboard as designed; however the setbacks for the B-4 must be met, as no topographical hardship is present to warrant any need to request a variance. Any variance would have to be approved by the Board of Zoning Appeals.
- Staff is requesting 5 additional sets of plans to be presented to Planning Commission.
- Staff has requested a formal written recommendation and opinion from Stan Harrison, Regional Director of the State Local Planning Assistance Office. (see attached memo)

Tim Adrien was present to represent Lamar Outdoor Advertising.

Motion was made by Mullins, seconded by Dutton to deny the site plan expansion. The motion to deny the site plan expansion passed unanimously, due to new setbacks out of compliance.

The Sullivan County Government Insurance Committee began its review of the County's July 2003 health insurance renewal in October 2002. During this time the Committee has discussed the current trends in healthcare costs, reviewed several options with the current carrier, John Deere Health, and has received several competitive options from BlueCross BlueShield of Tennessee.

We have compared the competitive proposal as to total cost, benefit and network differences and ease of administration. The entire negotiating process has been helpful in providing Sullivan County the opportunity to offer its employees excellent benefit choices while controlling the overall healthcare costs to the County. One option will give employees a choice of continuing their current John Deere Health in-network benefits at a decrease in their monthly costs for individual coverage.

Sullivan County Government has been very satisfied with John Deere Health, and there is no significant reason either from a cost, benefit, or service standpoint to recommend a change of carriers at this time. The consultant's recommendation is to renew with John Deere Health and to offer the three benefit options to the employees of Sullivan County Government.

His opinion was that the bid is not mandatory by the T.C.A. We, therefore, proceeded to request options and negotiate with JDH. At the direction of the Committee, Mr. Jones requested the best quote from JDH.
- 6. 02-25-03 Revised JDH proposal presented for fully insured at \$5.395 million.

Consultant recommended continuing to negotiate with JDH and not to bid this year.

Ms. Cowden requested a copy of JDH rates and was told by Mr. Jones to present all competitive proposals to consultant.

- 7. 03-25-03 Initial BCBST "P" proposal of \$5.378 million did not include "S" option. Mr. Jones requested consultant's recommendation. Consultant recommended JDH, and Committee voted 5-0 to approve recommendation.
- 8. 04-16-03 Second BCBST unsolicited proposal presented by broker and BCBST \$4,937 million "S" network.
- 9. 04-29-03 Third JDH proposal at consultant's request \$4,894 million. Network change to Select network.
- 10. 05-05-03 Third BCBST proposal. Benefit changes and a rate change on "P" and "S". "P" \$5.309 million and "S" \$4.882 million

Note: Since JDH is the current carrier, the consultant has negotiated with JDH during this process as requested by Sullivan County.

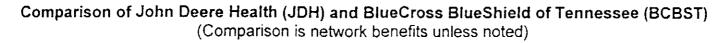
