### PROCLAMATION TO HONOR AND CELEBRATE THE Overmountain Victory Trail Association

Proclaimed by the Sullivan County Board of Commissioners: Samuel C. Jones, David Akard III, Andrew K. Cross, Mark A. Vance, Mark Hutton, Randy Morrell, Michael Cole, Joyce Crosswhite, Tony Leonard, Hershel Glover, Dwight King, Judy Blalock. Todd Broughton, Terry Harkleroad, Angie Stanley, Darlene Calton, Alicia Starnes, Colette George, Dong Woods, Larry Crawford, Gary Stidham, John Gardner, Hunter Locke; Richard S. Venable, Chairman

WHEREAS, annually members of the Overmountain Victory Trail Association march the commemorative trail originating in Abingdon, Virginia to the site of the Battle at King's Mountain, South Carolina preserving the heritage of our great Nation; and

WHEREAS, settlers occupying the area now known as Sullivan County, Tennessee played an important role in the history of our nation; and,

WHEREAS, in the early morning hours of September 23, 1780, the militia began their journey in Dunn's Meadow, Virginia and travelled toward what is now known as Sullivan County, Tennessee. The militia entered the eastern part of Sullivan County at Watauga Road traveling onward down (present-day) V.I. Ranch Road gathering with them more volunteers from the area who had gathered at Pemberton Oak to join the march. The militia continued further along Bristol Caverns Highway, Old Jonesboro Road, Weaver Pike and Pleasant Grove Road to Fort Womack. The following morning the militia crossed the Holston River at a well-known shallow spot called Choate's Ford (Bluff City), and continued their journey south along (present-day) Old Elizabethton Highway and U.S. Highway 19E toward what is now known as Carter County; and

WHEREAS, at this same time John Adair serving as Entry-Taker (tax collector), a State Officer of North Carolina, held in his possession the taxes collected from the residents of Sullivan County. At the request of Colonel John Sevier, Adair was asked to turn over the funds to out-fit the troops. Reluctantly Adair complied turning over between twelve and thirteen thousand dollars obtained from the citizens of Sullivan County. The money was used to obtain ammunition and necessary equipment for the volunteer militia which in turn allowed the troops to play an extremely pivotal role in the winning of the Battle of Kings Mountain, South Carolina and ensuring the independence of our Nation; and,

WHEREAS, each year, volunteers of the Overmountain Victory Trail Association present reenactments for local middle school students, as well as, free public presentations at local historical sites, such as Rocky Mount, to commemorate the victory march; and,

WHEREAS, the Overmountain Victory Trail Association was very instrumental in fostering the partnership between Sullivan County and the National Park Service for the commemorative trail. Sullivan County having four certified historic sites along the commemorative trail: Pemberton Oak, Fort Womack, Choate's Ford and Rocky Mount.





## **RESOLUTION TO approve Moratorium on State Standardized testing and accountability** associated with such testing for the 2020-2021 school year.

WHEREAS, Coronavirus Disease 2019 (COVID-19) is a global pandemic that can lead to serious illness or death and spreads through close contact among individuals; and

WHEREAS, beginning on March 12, 2020, Governor Bill Lee declared Tennessee to be in a state of emergency until June 30, 2020, pursuant to Executive Orders 14 and 36, due to COVID-19; and

WHEREAS, beginning on March 16, 2020, Tennessee Schools were closed for the remainder of the 2019-2020 school year, in response to requests made by Governor Bill Lee that they close to combat the spread of COVID-19; and

WHEREAS, on March 18, 2020, the Tennessee General Assembly approved the cancellation of state standardized testing for the 2019-2020 school year, due to the statewide closure of schools and subsequent lack of standardized instruction being delivered to students; and

WHEREAS, on June 22, 2020, the Tennessee State Board of Education approved Emergency Rule 0520-01-17-.01, which requires Tennessee School districts to provide students in grades one (1) through twelve (12) access to six and one half ( $6\frac{1}{2}$ ) hours of instructional time each school day during the 2020-2021 school year, even if there are school closures or disruptions related to outbreaks of COVID-19; and

WHEREAS, by Executive Order 50 signed by Governor Bill Lee, the state of Tennessee is to remain in a state of emergency until at least September 30, 2020 and COVID-19 continues to spread at a rapid rate in Tennessee; and

WHEREAS, Tennessee schools, in order to comply with State Board requirements, will likely have to engage in remote learning, in whole or in part, during the 2020-2021 academic school year due to the continued spread of COVID-19; and

WHEREAS, pursuant to State Board Emergency Rule 0520-01-17-.01, Tennessee school districts are required to each create and implement their own plans to facilitate continuous learning in light of the continued spread of COVID-19; and

WHEREAS, Tennessee school districts will be implementing different plans for learning from county to county across the state for the 2020-2021, based upon the needs of their students and COVID-19 outbreaks in each county; and

WHEREAS, Tennessee students will likely face significant academic and behavioral regression upon returning to school, having lost approximately two (2) months of standard instruction and attendance due to the extended closure; and

WHEREAS, when schools resumed in August 2020, students spent approximately five (5) consecutive months out of school; and

WHEREAS, Tennessee school districts will be focused not only on student growth and safety, but also on recoupment of academic and social and emotional skills lost during the extended closure; and

NOW, THEREFORE BE IT RESOLVED that the Board of County Commissioners of Sullivan County, Tennessee, assembled in Regular Session hereby supports and respectfully requests a moratorium on state standardized testing and accountability associated with such testing for the 2020-2021 school year, to include end-of-year examinations, end-of-course exams, and formative assessments throughout the year. The Sullivan County Commission requests that, if state standardized testing does continue in some format for the 2020-2021 school year, the results of that testing be used as metrics of student progress rather than to determine district rankings and scorings statewide and not count toward student grades or teacher and administrator evaluations, due to the disparity in 1) learning methods that will be used across the state in light of COVID-19; 2) resources available to each district in the state of Tennessee; and 3) internet access available to the student population across the state. Such a moratorium would permit school districts to focus on recoupment of students' academic and social /emotional skills lost during the extended school closure and the safety and welfare of students.

This resolution shall take effect from and after its passage. All resolutions in conflict herewith shall be and the same are hereby rescinded insofar as such conflict exists.




