### Amendment # 1 to replace original language in its entirety:

WHEREAS, The Sullivan County Board of Education has determined the need for an access road to West Ridge High School to ensure the safety of students and faculty;

NOW THEREFORE BE IT RESOLVED that the Board of County Commissioners of Sullivan County, Tennessee assembled in Called Session hereby approves:

- 1) Authorizing the Sullivan County Board of Education to purchase property and right-of-way to build an access road to West Ridge High School including an access driveway from Henry Harr as an alternate route.
- 2) Authorizing the Sullivan County Board of Education to purchase the identified property, using funds from its Reserve Account which will be reimbursed from Bond proceeds, to build an access road to West Ridge High School.
- 3) Authorizing that the property purchased will be owned by the Sullivan County Board of Education to be put to the highest use as determined by the Board.
- 4) Authorizing that upon completion the access road will be constructed to minimum or above compliance standards for Sullivan County and will be deeded to Sullivan County and/or the City of Kingsport.
- 5) Authorizing the Sullivan County Purchasing Agent to assist the Sullivan County Board of Education to secure professional services to design an access road and develop the bid document for the construction of the road to West Ridge High School.
- 6) Authorizing that the Sullivan County Finance Director will direct the issuance of \$6,000,000 in General obligation Bonds and the debt service of principal and interest will be serviced by funds provided by the Sullivan County Board of Education from its revenues.
