RESOLUTION TO APPROVE THE USE OF ACCUMULATED UNUSED SICK LEAVE TOWARDS YEARS OF SERVICE FOR THE PURPOSE OF QUALIFYING FOR RETIREMENT BENEFITS PROVIDED BY SULLIVAN COUNTY.

WHEREAS, Sullivan County provides paid sick leave as a benefit to its employees; and

WHEREAS, Sullivan County employees are allowed by Sullivan County to accumulate unused sick leave with no cap on the amount of sick leave that may be accumulated; and

WHEREAS, the State of Tennessee allows Sullivan County employees' unused accumulated sick days to be credited towards years of service for the purpose of qualifying for retirement benefits provided to Sullivan County employees as part of the Tennessee Consolidated Retirement System; however,

WHEREAS, Sullivan County does not allow its employees' unused accumulated sick days to be credited towards years of service for the purpose of qualifying for retirement benefits provided to Sullivan County employees by Sullivan County in addition to those benefits provided by the Tennessee Consolidated Retirement System, e.g., the provision of medical insurance to qualified retirees.

NOW, THEREFORE BE IT RESOLVED that the Board of County Commissioners of Sullivan County, Tennessee, assembled in Regular Session hereby approves allowing Sullivan County employees to be credited with all unused accumulated sick leave towards years of service for the purpose of qualifying for retirement benefits provided by Sullivan County in addition to those benefits provided by the Tennessee Retirement System, e.g., provision of medical insurance; and

BE IT ALSO RESOLVED that this resolution shall only apply from the date of passage forward and shall not apply to any Sullivan County employee who terminated employment with Sullivan County prior to the passage of this Resolution; and

BE IT ALSO RESOLVED that the Sullivan County Employee Handbook shall be amended to so reflect this change.

This resolution shall take effect from and after its passage. All resolutions in conflict herewith shall be and the same are hereby rescinded insofar as such conflict exists.

WHEREAS, Royal Enfield North America (RENA), a manufacturer and distributor of motorcycles through its dealer network across the United States and Canada, wishes to welcome Sullivan County EMS into the company's Royal Enfield EMT1 program; and

WHEREAS, RENA wants to award to Sullivan County EMS 2 (two) new 2023 Royal Enfield Himalayan motorcycles equipped with hard bags, hand guards and large engine guards for the department's use in lifesaving activities; and

NOW THEREFORE BE IT RESOLVED that the Board of County Commissioners of Sullivan County, Tennessee, assembled in Regular Session hereby approves the attached agreement between RENA and Sullivan County EMS for acceptance of the 2 (two) motorcycles awarded to the department by RENA; and

Agreement

This Agreement is made and entered into as of January 29, 2024 by and between Royal Enfield North America ("RENA"), a company incorporated in the State of Wisconsin and located at 226 N Water St, Milwaukee, WI 53202; and Sullivan County EMS ("SCEMS") an emergency medical service in the State of Tennessee located at 3191 Highway 126 #101, Blountville, TN 37617. Collectively "RENA" and "SCEMS" are referred to as the parties .

Whereas "RENA" is in the business of manufacture and distribution of Motorcycles, Parts, Gear and accessories through its dealer network in USA and Canada under its brand name "Royal Enfield". And "SCEMS" is in the business of EMS.

The parties hereto agree as follows:

- 1. RENA is desirous of providing motorcycles for the use by Emergency Medical Technicians (EMT) and SCEMS agrees to work with RENA on this project on a non-exclusive basis.
- 2. RENA agrees to provide 2 motorcycles to SCEMS as per the terms laid out in **Annexure 1** to this agreement.
- 3. SCEMS agrees to provide RENA with the services outlined in **Annexure 2**. SCEMS represents and warrants to RENA that it has the experience and ability to perform the services required by this Agreement; that it will perform said services in a professional, competent, and timely manner; that it has the power to enter into and perform this Agreement; and that its performance of this Agreement shall not infringe upon or violate the rights of any third party or violate any federal, state, and municipal laws.
- 4. **Confidentiality:** SCEMS acknowledges and agrees that in the course of performing under this Agreement, SCEMS may learn confidential, trade secret, and proprietary information concerning RENA's business, programs, and procedures ("Confidential Information"). SCEMS agrees to keep the Confidential Information in strict confidence, not to use any Confidential Information for SCEMS own purposes or for the benefit of any third party, and not to demonstrate or disclose, directly or indirectly, in any form or manner the Confidential Information to any person or entity. SCEMS shall treat as confidential and safeguard any such Confidential Information in at least the same manner as that SCEMS safeguards its own confidential or proprietary material or information of like kind. In addition, SCEMS agrees to treat all nonpublic personal information concerning RENA's customers that SCEMS obtains from any of RENA's employees or reports as confidential.
- 5. **Use of Name:** Either party may name the other party in its promotional, marketing, and other similar materials and refer to the relationship established between them under this Agreement provided that such party has obtained the prior written consent of the other party as to the form and content of such promotional, marketing, and other similar materials.
- 6. **RELATIONSHIP:** This Agreement is on a 'principal-to-principal' basis and does not create any employee- employer relationship between the Parties. The Service Provider and its representatives shall provide Services under this Agreement as an independent entity and nothing contained herein shall be deemed to create any partnership, joint venture between the Parties or a merger of their assets or their fiscal or other liabilities or undertakings or create any employment or relationship of principal and agent between the "RENA" and the "SCEMS".
- 7. **Entire Agreement:** This Agreement and the annexures attached here will constitute the complete agreement between the parties and supersedes all previous agreements or representations, written or oral, with respect to the subject matter hereof. This Agreement may not be modified or amended,

except in writing, signed by a duly authorized representative of each party. The waiver or failure of SCEMS to exercise any right provided for herein shall not be deemed a waiver of any further right hereunder. The rights and remedies of SCEMS set forth in this Agreement are in addition to any rights or remedies SCEMS may otherwise have at law or in equity. If any provision of this Agreement shall be held to be invalid, illegal, or unenforceable, the parties shall, at their option, modify such provision to the extent necessary to render it valid and the validity, legality, and enforceability of the remaining provisions shall in no way be affected or impaired thereby. The titles and headings of the Sections in this Agreement are for convenience of reference only, and are not to be considered in constructing the terms and provisions of this Agreement. Any and all notices shall be in writing and shall be delivered by hand or by nationally recognized overnight courier service sent by registered or certified U.S. mail, postage prepaid, return receipt requested, to the parties at the addresses set forth in the first paragraph of this Agreement, in each case to the attention of the Agreement signatory or specified representative. Prior to the filing of any legal action, RENA agrees to enter into non-binding mediation with SCEMS. The cost of said mediation will be shared equally by each party. If, after unresolved mediation, any legal action or other proceeding is brought for the enforcement of this Agreement, or because of an alleged dispute, breach, default, or misrepresentation in connection with any of the provisions of this Agreement, the successful or prevailing party or parties shall be entitled to recover reasonable attorneys' fees and other costs incurred in connection with that action or proceeding, in addition to any other relief to which such party or parties may be entitled.

8. **Jurisdiction:** This agreement shall be binding upon the parties, their successors and be enforced under the laws of the State of Wisconsin.

- 3. RENA will invoice the above two vehicles to its local dealer nearest to SCEMSs area of operation and the subsequent vehicle transfer to SCEMS shall take effect immediately upon execution of this agreement by both parties. Upon signing this agreement, the abovementioned vehicles shall belong exclusively to SCEMS and RENA shall have no further responsibility for, liability or interest in, said vehicles.
- 4. SCEMS will assume full ownership of the gifted motorcycles and will be responsible for titling and registering units in accordance with state and local agencies and with the help of the local dealer.
- 5. RENA will not have any further obligation beyond donating the 2 motorcycles to SCEMS who as the sole customer will be responsible for all other costs associated with owning the motorcycles.
- 6. RENA's normal warranty policy as applicable to any new motorcycle sold will be applicable to these 2 motorcycles also.

- 2. SCEMS will provide RENA with a monthly report on the EMT1 motorcycle usage and dispatches.
