RESOLUTION TO PROPOSE A REVISED BUDGET PROPOSAL FOR THE GENERAL PURPOSE SCHOOL FUND 2024-2025 BUDGET.

To the Honorable Richard S. Venable, Sullivan County Mayor and the Board of Sullivan County Commissioners meeting in Regular Session this 15th day of August, 2024.

RESOLUTION to PROPOSE A REVISED BUDGET PROPOSAL FOR THE GENERAL PURPOSE SCHOOL FUND 2024-2025 BUDGET.

WHEREAS during the budget process for the 2024-2025 fiscal year, many increases in expenditures were recognized; and,

WHEREAS increases in expenditures for a 15% raise for all employees were recognized totaling \$8,529,606.76; and,

WHEREAS other increases in expenditures for employee step increases, health insurance premiums, dental insurance premiums, utility costs, liability insurance premiums, and AED replacements to just name a few were also recognized; and,

WHEREAS due to a drop in student enrollment local revenue projections were also decreased in the amount of \$1,326,428; and,

WHEREAS these increases in expenditures and decreases in revenues created a gap of \$10,545,423 in expenditures over revenues; and,

WHEREAS the Board of Education began efforts to decrease expenditures through elimination of expenditures that were not a necessity and eliminating positions through attrition; and,

WHEREAS after recognizing additional funding through the TISA formula and diligently lowering expenditures, the gap was narrowed to \$6,854,565.00; and,

WHEREAS after receiving the commission's vote declining the original budget request, the Board of Education met on August 7, 2024 to discuss revising said proposed budget; and,

WHEREAS said meeting resulted in the following motions:

- 1. The board unanimously approved to give each employee a 15% raise with the administrators' increase being reduced to 15% of the equivalent degree and experience on the teacher's salary scale instead of the administrator's salary scale. This resulted in a savings of approximately \$150,000.00.
- 2. Since this proposal was utilizing undesignated fund balance to balance revenues and expenditures, it was agreed that only the amount needed to balance would be taken from the undesignated fund balance. Any unused funds would remain in the undesignated fund balance. It was also noted that history had shown that funds were added to the fund balance through past year budgets by utilizing conservative spending practices and fiscally sound operations.

NOW THEREFORE BE IT FURTHER RESOLVED THAT the Board of County Commissioners of Sullivan County, Tennessee, assembled in Regular Session hereby approves the 2024-2025

General Purpose School Fund Budget utilizing \$6,854,565.00 of fund balance with any remaining funds returning to the undesignated fund balance.

This resolution shall take effect from and after its passage. All resolutions in conflict herewith be and the same rescinded insofar as such conflict exists.
